#### Welcome:

## Approval of Agenda:

## Committee Reports:

- Treasury: This report was given by the Treasurer Kimberly Spurlock
  - The current balance in the associations account is \$37,979. The debt from the account was \$42,750 and a credit of \$22,000. The association will need to raise more money in order for the association to put on more events.
- o Membership: This report was given by the Membership chair Kisha Finch
  - Currently there are 1,094 members for 2024. There are 238 adult and 86 youth members. Last year there were 1,023 member. The Associations membership numbers are in good standing. There are 5 more sanctioned event that are due to happen the rest of the year.
- Officials: This report was given by the Officials Chair Betsy

- Currently there are 26 fully certified Officials. There are 10 Apprentice, 7 association, 5 national, and 4 master level officials. Also there are 3 para official's certified. The association needs a total of 33 officials to become in compliant. The basic rules will need to be reviewed to become certified.
- o Youth: This report was not given as the Youth chair was not present.
- Vice President: This report was not given as there is not current Vice President.
- o President: This report was given by the President Logan Taylor
  - Currently the state of the Nevada association is in rocky territory. The organization faces the challenge of gaining usage of facilities, a reduction in income, and the shortage of man power within the organization. The organization has to use facilitron in order to gain access to facilities instead of in kind agreements. Also, due to split in sanction and membership fees, it cuts the association to a 1/3 loss and 1/.66 loss. There are major vacancies in the sports and administrative committees. These will need to be filled. The Association will need to have the cooperation of the different committees for the association to run more smoothly and the board to help manage the organization as a whole. The Nevada association has been given the chance to host the Region 15 championships for 2025. The association will also need to host at least 15 championships a year. The association will need to the cooperation of the association as a whole and support from the community for the organization to get better.
